## Conditions of use certificate of conformity

- 1. Certificate of conformity issues in cases when the customer has a contract with certification body in which also includes follow-up period, if it required by the certification scheme, when the results of conformity assessment according certification scheme has positive decision and the customer has made payment in accordance with the terms of the contract;
- 2. Customer has no right to change or modify the content of certificate of conformity in any way.
- 3. Certificate of Conformity includes the following activities:
- 3.1. registration the certificate of conformity in certification body internal register information system www.stc.lv, notification according relevant procedures;
- 3.2. manufacturer information of any circumstances which may affect the validity of the certificate of conformity;
- 4. Customer's obligations during the term of the certificate of conformity:
- 4.1. reference to the certificate of conformity may be only specified to products according this certificate of conformity;
- 4.2. customer register complaints about the estimated production and inform the certification body.
- 5. The certification body has the right to suspend and cancel the certificate of conformity in the following cases:
- 5.1. detected incorrect reference, misleading or dishonest use of certificate of conformity;
- 5.2. the customer does not provide periodic monitoring, when intended;
- 5.3. if revealed significant discrepancies;
- 5.4. Customer has not fulfilled the financial obligations to the certification body;
- 5.5. Customer does not fulfil the conditions for supervision according the normative acts;
- 5.6. Customer has not completed specified corrective actions;
- 5.7. Customer does not want to extend the duration of the certificate;
- 5.8. There have been changes in legislation, but the Customer has not complied with these changes;
- 5.9. Discontinued the business activity of customer;
- 5.10. During the current follow-up inspection, the certification body shall examine the conditions of use certificate of conformity

## Conditions of use CE marking

- 1. Customer shall observe the following conditions of use CE marking:
- 1.1. The CE marking comply with requirements of Directive 2006/42 / EC Annex III;
- 1.2. The manufacturer or his authorized representative mark certified equipment with CE marking according normative acts. The CE marking serves as proof of product compliance statement according to one or more Directive conditions;
- 1.3. Machinery forbidden to mark with marks, signs and inscriptions, which a third party may be confused with the CE marking. The machine may be marked with other signs and symbols, if it does not reduce the CE marking visibility, legibility and meaning;
- 1.4. Notified body number be added to the CE marking in cases when provided full quality assurance procedure (Directive 2006/42/EK 12. article 3. point b) and c).
- Final conditions
- 2.1. Customer is obliged to immediately inform in writing the certification body in cases, if:
- 2.1.1. Owner of certificate of conformity changes its registered address of the location, or certified equipment technical data;
- 2.2. The certification body shall inform the Customer of any changes to the certification scheme by placing its website www.stc.lv;
- 2.3. During the current follow-up inspection, the certification body shall examine the of use CE marking.
